

Tribal Land Building Review Directory

Primary contacts and published building-review routes for proposed construction on tribal land in Arizona and New Mexico.

Important: Tribal governments are sovereign. County, city, or state approval may not replace tribal review. Confirm the review path before preparing permit drawings or beginning construction.

Suggested intake question: “We are preparing residential permit-review drawings for a project on tribal land. Which office must review the plans, and are tribal building, land-assignment or lease, utility, septic, cultural-resource, and chapter, district, or village approvals required before construction?”
